Terms and Conditions

1 Deposit, Payment of Purchase Price, Fees

Buyer has paid a deposit of \$350 with a payment balance of \$1,850 due upon release of the dog to the Buyer. GoodDog app is the preferred form of payment. Payment may be made in cash. Alternatively, Zelle, Venmo or PayPal is acceptable with a 3% up-charge. In case of a personal check, it will need to be received 3 business days prior to puppy pick up.

A boarding fee of \$35/day will be charged for each day the puppy is boarded by the seller beyond the agreed upon pick up date, Tuesday March 26th

2 Transfer of Ownership

Upon payment in full of the purchase price, Seller shall promptly take all actions to officially transfer ownership of the puppy to Buyer.

3 Sellers Representations and Warranties

Seller represents and warrants to Buyer that:

- Seller has the legal and true ownership of dog and that Seller has full rights and authority to sell the dog
- The Seller guarantees that the dog is as described - a miniature goldendoodle breed
- The dog is in good health and has been examined by a licensed veterinarian at the cost of the Seller.
- The Buyer has 2 business days from the pick-up date to have the dog examined by their own licensed veterinarian at the Buyers sole cost. If the dog fails the examination and is deemed an unhealthy dog, Buyer may return the Dog with a written statement from the veterinarian. The Seller will obtain a second opinion from their vet and if results are conclusive, the Seller will provide the Buyer a full refund and retain the puppy.
- Failure by Buyer to have the Dog examined within a 2 day period will nullify this warranty. If Buyer chooses to keep the puppy, no replacement will be issued and all medical costs and treatment are sole responsibility of the Buyer.
- This Guarantee is for the general health of the puppy at the time is is placed in the care of the Buyer. Maintaining good health and safety of the puppy is the sole responsibility of the Buyer at the time ownership is transferred.
- Buyer is responsible for all medical costs of their puppy. No refunds will be given. This guarantee covers only the original Buyer and is not transferrable.

4 Fitness of Purpose

The dog was bred as a companion animal and Seller does not provide any warranty as to the dogs fitness for any specific purposes such as obedience trials, show ring performance and/ or other breeding purposes.

5 Buyers Representations

Buyer represents to Seller that:

- Buyer will have the dog spayed or neutered by the age of 6-9 months. Failure to do so can result in legal actions to reclaim possession of the dog. The dog is not permitted to be used for breeding.
- The dog will reside with Buyer as a companion pet to the Buyer and Buyers family
- Buyer will keep the dog in an enclosed area of adequate size and will take precaution to create a place of safety for the dog at all times. Buyer will not keep the dog chained or tethered or permanently house the dog in a kennel.
- Buyer will provide the dog with nutritious food and necessary veterinary care, including the deworming, heart worm prevention and regular vaccinations (including rabies).
- Buyer is not acting as an agent for any other person or business in purchase of the dog.
- Buyer will not sell, give or lease dog to a pet shop, retail store, dog dealer, animal testing facility, research facility or an agent for any such business or facility.
- In the event Buyer sells the dog to a new owner, buyer shall ensure that the new owners agrees in writing to comply with the terms of this agreement.
- At any time, the Buyer may return the dog to the Breeder to avoid being placed in a shelter or abandoned. No refund will be given.

6 Entire Agreement

This agreement represents the entire agreement between the parties. Seller and Buyer have made no other agreements, promises, representations or warranties, express or implied unless specifically stated in this agreement
